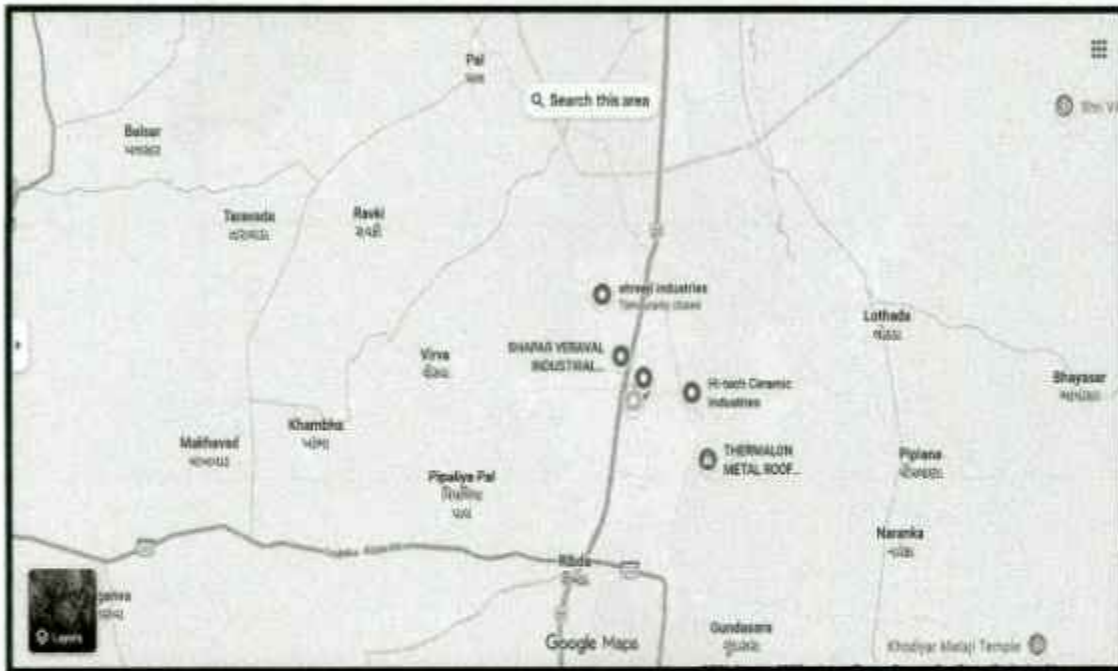

Your Directors are pleased to present the 1st Annual Report of the Company together with the audited financial statements for the financial year ended 31st March 2025.

1. FINANCIAL SUMMARY / HIGHLIGHTS

2. STATE OF COMPANY'S AFFAIRS

A brief description of the Company's business, operations, performance, and significant developments:

Antala Industries Limited, incorporated on 05th August, 2024, is engaged in the manufacturing of polymer, synthetic, and PVC water storage tanks. The company focuses on delivering high-quality, durable, and eco-friendly storage solutions for domestic and industrial use. During the year, initial operations commenced with the setup of manufacturing infrastructure and procurement of key machinery. Market outreach and branding efforts were initiated to establish a strong presence in the polymer tank segment. The company is poised for growth with plans to scale production and expand its distribution network in the upcoming year.

During the year under review, the Company has total Income of Rs. 2151.65/- (in Lakhs) and the Company has earned profit of Rs. 130.47/- (in Lakhs) during the year ended 31.03.2025.

3. CHANGE IN THE NATURE OF BUSINESS, IF ANY

During the year under review, there was no change in the nature of the business of the Company.

4. SHARE CAPITAL

Authorized Share Capital:

As on 31st March, 2025, the Authorized share capital of the Company INR 8,50,00,000/- (Indian Rupees Eight Crores Fifty Lakhs Only) divided into 85,00,000 (Eighty-Five Lakhs Only) Equity Shares of INR 10/- each.

Paid-up Share Capital:

During the year under review, the following changes occurred in the share capital of the Company:

1. At the time of incorporation on 5th August, 2024, the paid-up share capital of the Company was Rs. 3,40,43,150/- (Indian Rupees Three Crore Forty Lakh Forty-Three Thousand One Hundred Fifty only), divided into 34,04,315 (Thirty-Four Lakh Four Thousand Three Hundred Fifteen only) equity shares of face value Rs. 10/- (Rupees Ten only) each.
2. On 14th September, 2024, the Company issued 1,77,721 (One Lakh Seventy-Seven Thousand Seven Hundred Twenty-One only) equity shares on a preferential basis for consideration other than cash at an issue price of Rs. 95/- (Rupees Ninety-Five only) per equity share, in accordance with the provisions of Section 62(1)(c) of the Companies Act, 2013.
3. On 3rd October, 2024, the Company issued 15,04,455 (Fifteen Lakh Four Thousand Four Hundred Fifty-Five only) bonus equity shares of face value Rs. 10/- (Rupees Ten only) each, in accordance with the provisions of Section 63 of the Companies Act, 2013.
4. On 6th December, 2024, the Company issued 1,11,111 (One Lakh Eleven Thousand One Hundred Eleven only) equity shares at an issue price of Rs. 45/- (Rupees Forty-Five only) per equity share on a rights basis, in accordance with Section 62(1)(a) of the Companies Act, 2013.
5. On 13th January, 2025, the Company issued 1,13,000 (One Lakh Thirteen Thousand only) equity shares at an issue price of Rs. 45/- (Rupees Forty-Five only) per equity share on a rights basis, with the approval of the Board of Directors and shareholders, in accordance with Section 62 of the Companies Act, 2013.
6. On 29th March, 2025, the Company issued 1,11,111 (One Lakh Eleven Thousand One Hundred Eleven only) equity shares at an issue price of Rs. 45/- (Rupees Forty-Five only) per equity share on a rights basis, pursuant to Section 62 of the Companies Act, 2013.

Consequently, as on 31st March, 2025, the paid-up share capital of the Company stood at Rs. 5,42,17,130/- (Indian Rupees Five Crore Forty-Two Lakh Seventeen Thousand One Hundred Thirty only), divided into 54,21,713 (Fifty-Four Lakh Twenty-One Thousand Seven Hundred Thirteen only) equity shares of face value Rs. 10/- (Rupees Ten only) each.

5. DEPOSITS

During the year under review, your Company has not accepted any deposits, falling within the meaning of Section 73 of the Companies Act, 2013 and the Companies (Acceptance of Deposits) Rules, 2014.

6. **DIVIDEND**

For the year under review, the Directors do not recommend any dividend for the Financial Year 2024-25.

7. **RESERVES**

During the period under review, the Company has not transferred any amount to the General Reserve.

No material changes and commitments affecting the financial position of the Company occurred between the end of the financial year to which these financial statements relate and the date of this report.

However, during the year under review, the Company altered its Object Clause of the Memorandum of Association pursuant to the provisions of the Companies Act, 2013. The alteration was approved by the shareholders of the Company by way of a Special Resolution on passed on 21st October, 2024 and the necessary filings were made with the Registrar of Companies.

All related party transactions that were entered into during the financial year ended March 31st, 2025, were in the ordinary course of business. Therefore, the provisions of Section 188 of the Companies Act, 2013 were not attracted. 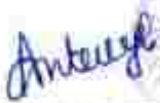

SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES AS on 31/03/2025

1) BASIS OF PREPARATION OF FINANCIAL STATEMENTS:
