Opinion

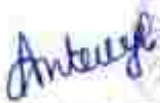

SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES AS on 31/03/2025

1) BASIS OF PREPARATION OF FINANCIAL STATEMENTS:

- a) The Financial Statements are prepared under historical cost convention and on accrual basis of accounting, unless otherwise stated, by following going concern assumption and conform in all material aspects to the statutory provisions, regulatory guidelines and Generally Accepted Accounting Principles in India. The financial statements comply with the applicable mandatory Indian accounting standards issued by the Institute of Chartered Accountants of India and Accounting Standards notified under the relevant provisions of the Companies Act, 2013.
